NO.6 A deployment specialist running configPE.bat(CPIT) in an IBM WebSphere Application Server (WAS) environment installs IBM FileNet Content Platform Engine V5.2 in a Microsoft Windows environment. It fails giving an out-of-memory error.

The java.lang.OutOfMemoryError: Java heap space error message in the SystemOut.log file for WAS indicates that the Java Virtual Machine ran out of heap space.

As a deployment specialist, which two following steps need be taken to address this issue? (Select two.)

- A. Do not replace or change the cpit.properties file.
- B. Run 5.2.1-CPIT-WIN.exe after emptying the recycle bin.
